The meeting was called to order at 11.15 a.m. by the Project Manager. A word of prayer was said followed by a short introduction.

MIN 2/3/8/2022-2023-PRESENTATION OF TENDER DOCUMENT AND SCOPE OF WORKS

The Procurement Officer requested the contractors to read the whole Tender document carefully and not focus on certain areas at the expense of others. He mentioned the stages of Evaluation and the requirements: Mandatory requirements, Technical evaluation, Financial Evaluation and Due diligence. He said the Mandatory requirements were as key as the BOQs just as meeting other parts of the evaluation expectations was.

Project Manager explained to contractors the scope of work to be implemented under the UPC 8th call project as follows:-

- a) Pipeline extension 4.8km.
- b) Supply and installation of cold water meters 250 No.
- c) Construction of ground level 150M³ masonry tank.
- d) Construction of 2No. closed water kiosk.

He shared the challenges encountered during implemenation of previous projects and delays because of contractors not paying much attention to a newly signed contract but concentrating on their ongoing projects elsewhere.

MIN 3/3/8/2022-2023-PLENARY SESSION

The Project Manager welcomed those in attendance to seek any clarification on any matter or share any experience.

The Project Manager invited The Commercial Manager to make his presentation. The Commercial Manager highlighted the importance of the exercise of pre tender meeting and site visit in as far as conforming to compliance with the PPAD 2015 Act is concerned. He said this is an open process and emphasised that the contractor who would be successful is expected to do quality work.

The Acting Managing Director spoke at length on expectation of quality work being done by the successful bidder. He said the process will be fair and thorough especially the evaluation and due diligence. He said work will strictly be done according to specifications and payment made after achieving the respective milestones as per the contract thus short cuts will not be entertained. On the tank he said pressure testing will be done to ensure there was no 'weeping' of the tank. This being donor funds he expected both the employer and contractor to do their part above board and complete the project within the specified period.

The Director who chairs the technical committee and represented the BOD during the exercise implored whoever would be successful to carry out quality work. For those who will not be successful she asked them to be on the look out as there are more projects on the way and not to get disheartened.
